Commander's Message:

I would like to thank all those Legionnaires from Erie County who were able to dig out and attend Department of NY 105th Midwinter Conference last weekend in Albany.

While the weather limited this year's attendance, I can attest that it was a very productive conference and I would encourage all Erie County 35 Posts to send representatives to future conferences and conventions, not only to participate in the many Training Opportunities, but to get to know fellow Legionnaires and Department Leadership Team.

I am pleased to report that the Department Executive Committee expedited approval of Erie County/Brounshidle Post Limited Electronic Gaming Resolution and we are moving forward to encourage all of New York 821 American Legion Posts to pursue Grass Roots Efforts to contact and encourage each of your Assemblyman & Senators to support the legislation to pass NY Assembly Bill 4813 & Senate Bill 1959. While in Albany, I met with representatives of Arrow International Inc. who manufacture traditional Bell Jar Games and Electronic Bell Jar gaming machines. We spoke at length and when this gaming Bill becomes law, Arrow International is willing to provide Electronic Bell Jar Machines at no up-front cost to our Posts, in exchange for a 65/35 share. (65% of proceeds go to Post, 35% to Arrow)

Arrow representative is sending me pamphlets detailing the impact that Electronic Bell Jar gaming has experienced in surrounding states and stated that we can expect to experience a 4 to 5x increase in Bell Jar revenue for a fraction of the effort managing this new revenue stream. Where traditional Bell Jar game management has been approximately 2 plus hours a week, with less handling of tickets and online reporting the Electronic Gaming management is approximately 10 Minutes a week...

Americanism – VC Paul Wackowski

The Spanish and American War was a conflict that took place in 1898 between the United States and Spain. The war was primarily fought over Spanish colonial possession in the Caribbean and the Pacific, including Cuba, Puerto Rico, the Philippines, and Guam. Several factors led to the outbreak of the War.

Cuban War for independence: Cuba had been fighting for independence from Spain for many years, and the United States had been sympathetic to the Cuban cause due to its strategic and economic interests in the region.

Yellow Journalism: Sensationalized and often exaggerated reporting by newspapers, known as "Yellow journalism", fueled public outrage in the United States over Spain's harsh treatment of the Cuban people.

Sinking of the USS Main: The American battleship USS Main exploded and sank in Havana Harbor in February 1898. Although the cause of the explosion was not definitively determined, the event was used as a rallying cry for was by those in the United States who sought intervention in Cuba.

The conflict itself was relatively short, lasting just a few months, and resulted in a decisive victory for the United States. The war formally began in April 1898 and ended in August of the same year. The U.S. military achieved significant victories in Cuba, the Philippines, and Puerto Rico.

The Treaty of Paris, signed in December 1898, formally ended the war and forced Spain to cede control of Cuba, Puerto Rico, Guam, and the Philippines to the United States. This marked the end of the Spanish Empire's colonial rule in the Americas and the beginning of an increased US presence as a major power in the region.

The war had far-reaching consequences for both countries. For the United States, it marked the emergence of the country as a global power and set the stage for increased involvement in international affairs. In Spain, the defeat and loss of its colonies led to a period of national introspection and soul-searching known as the "Generation 98".

Overall, the Spanish-American War had a significant impact on the history of the United States, Spain and the regions involved in the conflict, shaping the course of events well into the 20th century.
